CALLED TO ORDER AT 9:30 AM WITH THE PLEDGE OF ALLEGIENCE

PUBLIC COMMENT: TOM TURRELL BROUGHT UP CONCERNS WITH THE LOW TAX RATE. MR. TURRELL ALSO BROUGHT TO THE BOARD'S ATTENTION THE POSSIBILITY OF RIVERSIDE POSSIBLY HAULTING SERVICES IN THE FUTURE. MIKE MITCHELL ASKED ABOUT THE REPAIR PLANS FOR THE GENERATOR ON ENGINE 91 AND THE LIGHT ON TOP OF ENGINE 92. CHIEF JIM SPOON STATED A NEW SOLENOID WILL BE REPLACED TO ATTEMPT TO RESOLVE THE ISSUE. MR. MITCHELL ALSO STATED HIS CONCERN WITH RIVERSIDE ASKING FOR MONEY FROM FIRE DISTRICTS SINCE THEY ARE NOT TAKING INTO CONSIDERATION THE REVENUE FROM THE ER.
