BOARD OF TRUSTEES SPECIAL MEETING MINUTES

DATE: APRIL 10TH, 2023

CALLED TO ORDER AT 6:00 PM WITH THE PLEDGE OF ALLEGIENCE

ROLL CALL: JOEY BAUD- PRESENT, JORDAN LEE- PRESENT, DAVID HORN-PRESENT

GENERAL PUBLIC: CHIEF JIM SPOON, TOM TURRELL, KEVIN HACK, AL PONTON

PUBLIC COMMENT: MR. TURRELL ASKED IF THE AMBULANCE BEING CALLED TO THE JUNCTION WAS COUNTED AS A CHANGE OF QUARTERS AND THE ANSWER IS YES. HE ALSO ASKED WHAT THE TURN AROUND TIME FROM HOSPITAL BACK TO AMBULANCE QUARTERS IS. THE ANSWER WAS THAT AS SOON AS THE PATIENT IS OFF THE STRETCHER THE AMBULANCE BEGINS IT'S RETURN.

KEVIN STATED THE FOLLOWING: 8 AMBULANCES CURRENTLY RUNNING, DOWN FROM 11 LAST YEAR. THE SUPERVISOR VISITS EACH STATION EVERY DAY. NO LONGER WILL THE AMBULANCES BE DOING NON EMERGENCY TRANSFERS FROM THE HOSPITAL. AVERAGE RESPONSE TIME IN MOMENCE IS 6 MINUTES. WHETHER IT IS AN AMBULANCE OR SUPERVISOR TO STAY ON THE SCENE OF A FIRE IS TO BE DISCUSSED AT DETERMINED BY THE LEADERSHIP ON SCENE. RIVERSIDE WILL BE ASKING FOR FUNDS TO HELP RELIEVE THE \$80,818.17 DEBT FROM SERVING MOMENCE. NO SPECIFIC AMOUNT HAS BEEN ASKED YET. PAYMENT WILL BE ASKED FOR IN NOVEMBER. JORDAN LEE ASKED FOR SAVE RATE DATA AND DATA ON ALS VS BLS CALLS, NEITHER SET OF DATA WERE AVAILABLE IMMEDIATELY.
