CALLED TO ORDER AT 9:30 AM WITH THE PLEDGE OF ALLEGIANCE

PUBLIC COMMENT: TOM TURRELL APPLAUDED THE DISTRICT FOR REPLACING THE GENERATOR FOLLOWING THE STORM.

TREASURERS REPORT: THE EXPENDITURES AND REVENUE FROM APRIL 24TH, 2026 THROUGH MAY 30TH, 2026 WERE READ BY JORDAN LEE. EXPENDITURES INCLUDED \$165 TO AIR ONE EQUIPMENT, \$508.34 TO PERFORMANCE CHEMICALS, \$2,727.27 TO MACQUEEN, \$30,000 TO CHARLES EQUIPMENT AS A DOWN PAYMENT FOR THE GENERATOR, \$6,898.03 TO STEELE COLLISION FOR THE CHIEF'S VEHICLE HAIL DAMAGE, JOEY BAUD MADE A MOTION TO APPROVE THE TREASURERS REPORT, SECONDED BY DAVE HORN.
