WE HAVE RECEIVED AUTO/MUTUAL AID 23 TIMES AND HAVE PROVIDED AUTO/MUTUAL AID 47 TIMES. THERE WAS 118 EMS RELATED RESONSES INCLUDING ASSISTING RIVERSIDE 56 TIMES.
